

Technical information - Goods vehicle Movement Service (GVMS) CHIEF changes

Background / introduction

To achieve full customs control on goods, at locations with limited space or infrastructure, the Government introduced the Goods Vehicle Movement Service (GVMS) to support the Pre-Lodgement model for both imports and exports and to facilitate Transit movements.

From 1 January 2021 traders, hauliers and carriers are required to have a Goods Movement Reference (GMR) to move goods from the EU to GB (transit movements only) or GB to NI. Once full customs checks are in place from January 2022, GVMS will be available to use for UK/EU imports and exports.

Goods Movement Reference (GMR)

At border locations operating the GVMS, hauliers will be required to provide the carrier with a GMR number obtained from the GVMS. The GMR is a unique number beneath which individual customs, transit and safety & security declaration numbers will be linked together for that vehicle/container.

Each GMR number is valid for a single crossing and can be used only once.

In order to support GVMS we have made the following changes to the CHIEF GB/EU import declaration processes.

Imports changes

Declarants will be required to pre-lodge a customs declaration, (Full Frontier or Simplified Frontier), into CHIEF before the goods arrive at the exiting EU port or Eurotunnel premises.

To support GVMS, CHIEF and the Trade interface, the declarant must complete the following when submitting a customs declaration when the goods are moving via a location using GVMS:

- Goods Location (SAD box 30 GDS-LOCN-CODE) (from gov.uk) to capture the 'RoRo' location.
- Header AI Statement 'RRS01' (SAD box 44 HDR-AI-STMT). The solution introduces a new header AI statement 'RRS01' to indicate that the declaration is of interest to GVMS
- An Import Entry marked as 'of interest to GVMS' (AI Statement 'RRS01' present) cannot also be declared as inventory linked (SAD box 44h: MASTER-UCR not null). An inventory linked Entry is expected to be progressed, (including Arrived), by a CSP Inventory system
- Traders will be permitted to add or remove AI statement 'RRS01' on their declaration from when it is pre-lodged up until the point of arrival at embarkation by GVMS. Once the entry is arrived, amendment to remove or add AI statement 'RRS01' will no longer be permitted

Note: Failure to provide the 'RRS01' header statement within the declaration will result in GVMS not being able to arrive the declaration.
